# Notice of race

## 1. RULES

1.1 The regatta will be governed by the rules as defined in the Racing Rules of Sailing edition (2021-2024)

1.2 The Polish Yachting Association Regulations "Rules for organization of sports regattas" will apply.

1.3 In the rules for this regatta:

[DP] means that the penalty for a breach of that rule may, at the discretion of the protest committee, be less than disqualification.

[SP] means that a standard penalty may be applied by the race committee without a hearing or a discretionary penalty may be applied by the jury with a hearing.

[NP] means that a boat may not protest another boat for breaking that rule. The jury may refuse to hold a hearing when a boat protest based on these rules.

## 2. [DP] ADVERTISING

Boats may be required to display advertising and numbers chosen and supplied by the Organizing Authority.

## 3. ELIGIBILITY AND ENTRY

3.1. The event is open to all boats of the classes mentioned in point 4.1 of this Notice of race.

3.2. All entries shall be made online at the <https://portal.sailingnet.pl/>

3.3. The World Sailing Code of Eligibility applies to all competitors.

3.4. Final entry confirmation needs to be done in the regatta office in the harbour Port Jachtowy Dziwnów within the deadline specified in point 6.1.

3.5. Listed below documents may be required during the entry confirmation procedure.

- fee payment confirmation,
- Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of 1.500.000 EUR per incident or the equivalent.
- consent of a parent/legal guardian to start in the competition (applies to underage competitors),
- yacht certificate,
- current medical examination, in the case of competitors under 23 years of age,
- amateur/sports license from Polish Yachting Association (applies Polish sailors)
- advertising license from Polish Yachting Association (if applicable)

## 4. FEES

4.1 Entry fees are as follows:

- 4.3 The fee is nonrefundable, except for the event being cancelled by the organizing authority.

## 5. COMPETITION FORMAT

If there are more than 60 entries in one class, the Race Committee may decide to divide the fleet series into groups. Classes, which will be divided, will sail in eliminations and final races.

## 6. EVENT SCHEDULE

6.2. 9 races are planned for all classes.

6.3 On the last scheduled day of racing (27.08.2023), no warning signal will be made after 13:30, if regatta is valid. If there aren't enough races to make regatta valid, no warning signal will be made after 17:00.

## 7. EQUIPMENT INSPECTION

- 7.1. All boats must be available for the inspection from 9:00 on the first day of planned races.
- 7.2. Boats may be inspected at any time.

## 8. SAILING INSTRUCTION

## **9. REGATTA PLACE**

9.1. When berthing boats shall be kept in their assigned place at Port Jachtowy Dziwnów, ul. Żeromskiego 30

9.2. Racing area is Baltic Sea.

## **10. COURSES**

Courses will be described in Sailing Instruction.

## **11. PENALTY SYSTEM**

11.1. Despite protests described as [DP], the Sailing Instruction may include standard penalties, which are imposed by the Race Committee without a hearing. This changes RRS 63.1 and A5.

## **12. SCORING**

12.1. Three races are required to be completed to constitute a championship.

12.2. The other results for age categories (if applicable) shall be extracted from the overall score.

12.3. When fewer than 4 races have been completed, a boat's series score shall be the total of her race scores. Then 4 or more races have been completed, a boat's series score shall be the total of her race scores excluding the worst score.

## **13. SUPPORT PERSON VESSELS**

13.1. All support person vessels shall be registered with the organizing authority while registering.

13.2. Support person vessels shall be insured with a validity third-party liability insurance with a minimum cover of 500.000 EUR, which needs to be presented during the registration.

## **14. [NP][DP] BERTHING**

14.1. When berthed, boats shall be kept in their assigned place at the boat park.

14.2. Fee covers berthing for the days when registration and races take place. For longer berthing, the berthing fee needs to be covered individually.

## **15. [DP] RADIO COMMUNICATION**

Boats, which take part in races, cannot use radio transmission, text messages, phone calls and other mobile devices which enable communication, despite the devices provided by the organizer.

## **16. PRIZES**

The Organizing Authority will provide prizes to the top 3 boats in general classification and other classifications if applicable.

## **17. IMAGE RIGHTS**

17.1. Entering the regatta, the competitor agrees to:

a) free use of their image by the Organizers and sponsors during photos, films and other reproductions during the regatta and in all materials related to the regatta,

b) processing of personal data contained in the application for the regatta for the purpose of conducting the competition, by the personal data administrator - Polish Yachting Association with its registered office in Warsaw (03-901), al. Fr. J. Poniatowskiego 1, has been instructed that providing data is voluntary, but necessary to participate in the regatta and that he has the right to access and correct his/her data,

c) placing data (1) in a publicly available list: regatta results, starting lists (1) Consent applies to the following data: - first name(s) and surname, - ID card/licence number and expiry date, - e-mail address, - date of birth.

17.2. [DP][NP] Competitors may be obliged to take part in the interview while the event.

## **18. RISK STATEMENT**

All competitors take part in the regatta at their own risk. See Law 3 'Decision to Race'. The organizer shall not be liable for any damage, personal injury or death incurred in connection with participation in the regatta, either during, before or after the regatta.
